Failure to comply with this instruction will Result in the shipper being responsible for paying any extra shipping insurance costs.**

- ii. For all collect (Cormer pays) shipments that are on a skid/pallet (**Less than 10,000 lbs.**), shipping from anywhere in Canada to Cormer Group Industries, ship via **Purolator Freight expedited service** on Cormer Account# **P-1068**.
- iii. For all collect (Cormer pays) shipments that are **more than 10,000 lbs.** shipping from anywhere in Canada to Cormer Group Industries, please contact Cormer by email at [Logistics@cormeraerospace.com](mailto:Logistics@cormeraerospace.com) with shipment weight, number of packages & dimensions and Cormer will advise the service to be used.

For all collect (Cormer pays) Courier shipments that are not on a skid, **more than 50 lbs.**, shipping from the U.S.A. to Cormer Group Industries, please contact Cormer by email at [Logistics@comeraerospace.com](mailto:Logistics@comeraerospace.com) with PO no., number of packages, shipment weight & dimensions and Cormer will advise with which carrier and what level of service to use.
- iii. For all collect (Cormer pays) Freight shipments (on skid/pallet) (**more than 250 lbs. and Less than 5,000 lbs.**), shipping from U.S.A. to Cormer Group Industries, ship via **FedEx LTL Priority service** using Cormer Account Number **517189294**.
- iv. For all collect (Cormer pays) shipments that are more than 5,000 lbs., shipping from anywhere in the U.S.A. to Cormer Group Industries, please contact Cormer by email at [Logistics@comeraerospace.com](mailto:Logistics@comeraerospace.com) with shipment weight, number of pieces and dimensions and Cormer will advise..
